\_\_\_\_\_ **Package C** – Full day coverage with 2 photographers, online proofing with Pictage, a minimum of 300 proofs in a proof magazine, and an EP signature print, an engagement portrait session with 20 4x6 proofs in an Art Leather Album (B&W or color), and a 30 page, 11x14 custom-designed coffee table wedding album, a miniature companion wedding album, and a 200.00 product credit

***By signing below, I/we have officially requested the services of Expressive Photography for our wedding on \_\_\_\_\_ for the services marked above. The balance, once paid, shall also be non-refundable. If the balance is not paid by the day of the wedding stated above, the requested photographic services will not be carried out. I/we agree to all of the terms in this Agreement, and acknowledge receipt of a complete copy of the Agreement signed by both parties. Each person signing as Bride, Groom, or Client below shall be fully responsible for ensuring that full payment is made pursuant to the terms of this Agreement.***

## Terms and Conditions

- 1. Exclusive Photographer.** The Photographer shall be the exclusive photographer retained by the Client for the purpose of photographing the wedding. Family and friends of the Client shall be permitted to photograph the wedding as long as they shall not interfere with the Photographer's duties and do not photograph poses arranged by the Photographer.
- 2. Photographic Materials.** All negatives shall be the exclusive property of the Photographer. The Photographer shall make these negatives available to the Client for purchase two years from the date of their wedding. Any changes to this agreement must be made in writing and signed by the Client and Photographer.
- 3. Copyright and Reproduction.** The Photographer shall own the copyright in all images created and shall have the exclusive right to make reproductions. The Photographer shall only make reproductions for the Client or for the Photographer's portfolio, samples, self-promotions, entry in photographic contests or art exhibitions, editorial use, or for display within or on the outside of the Photographer's studio. If the Photographer desires to make other uses, the Photographer shall not do so without first obtaining the written permission of the Client.
- 4. Client's Usage.** The Client is obtaining prints for personal use only, and shall not sell said prints or authorize the reproductions thereof by parties other than the Photographer. If the client is obtaining a print for a newspaper announcement of the wedding, the Photographer authorizes the Client to reproduce the print in this manner. In such event, the Client shall request that the newspaper run credit for the Photographer adjacent to the photograph, but shall have no liability if the newspaper refuses or omits to do so.
- 5. Failure to Perform.** If the Photographers cannot perform this Agreement due to fire or other casualty, strike, act of God, or other cause beyond the control of the parties, or due to the Photographers' illness, then the Photographers shall make every effort to locate substitute photographers. In the event that only one of the Photographers is not able to perform this agreement due to the reasons already mentioned above or due to reason(s) stated at the time of the signing of this contract, a substitute photographer will be hired to replace the absent Photographer. Out-of-state weddings will be dealt with on a case-by-case basis. Expressive Photography will only utilize substitute photographers which are representative of the quality and style which Expressive Photography stands for and represents.
- 6. Photographer's Standard Price List** – The charges in this Agreement are based on the Photographer's Standard Price List. This price list is adjusted periodically and future orders shall be charged at the prices in effect at the time when the order is placed.
